

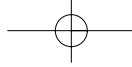

CONGRESSIONAL RECORD ON CHOICE

107th CONGRESS, 2nd SESSION

As we publish the *2002 Congressional Record on Choice*, a woman's right to choose hangs by a thread. The Senate fire-wall is down. Bolstered and encouraged by results of the mid-term elections, President Bush is preparing to work in close coordination with the anti-choice-controlled 108th Congress to stack courts with ideologically conservative judicial nominees and pass legislation further curtailing reproductive freedom. Moreover, at least one Supreme Court retirement is likely around the corner.



This is a bittersweet moment for the pro-choice movement. As we celebrate *Roe v. Wade's* 30th anniversary and the freedoms *Roe* guaranteed American women, we reaffirm our commitment to uphold and defend our rights. Yet, freedom of choice now faces undeniable perils:

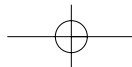
The coming 108th Congress includes 142 fully pro-choice House members, of 435; in the Senate, pro-choice senators number only 33 of 100. Since anti-choice forces gained control of the House and Senate in 1994, Congress has cast 148 votes on reproductive-rights and health-related issues. Pro-choice Americans lost all but 25 of those votes.

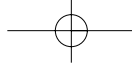
While in pro-choice hands, the Senate served as the firewall between anti-choice forces and many further restrictions they would impose on Americans' reproductive freedom. With anti-choice Sen. Bill Frist (R-TN) taking leadership of the Senate in the 108th Congress, anti-choice forces will control all elected branches of federal government. A host of bills and judicial nominees are already in the queue. In the face of this challenge, NARAL Pro-Choice America is prepared to intensify its work in defense of the constitutional right to choose.

The *2002 Congressional Record on Choice* is a record of reproductive-rights votes taken during the second session of the

107th Congress. During the course of the year, one or both houses of Congress passed the following restrictions on reproductive freedom:

- ★ For the fifth time, the House passed legislation criminalizing abortion procedures (the so-called “partial-birth” abortion ban)—despite the fact that the Supreme Court has ruled such bans unconstitutional.
- ★ The House passed the Child Custody Protection Act, a bill criminalizing anyone other than a parent—including a grandparent, adult sibling, or religious counselor—who accompanies a minor across state lines for an abortion if the home state's mandated parental-consent law has not been met.
- ★ The House passed new legislation enacting the most wide-sweeping refusal clause ever seen at the federal level—effectively allowing health-care companies to impose a “gag” rule against abortion services and information.
- ★ Congress continued bans on abortion access for women who depend on the federal government for their health care: Medicaid and Medicare clients, U.S. servicewomen and military dependents serving overseas, federal employees, residents of the District of Columbia, and women in federal prison.





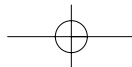
Additionally, the Bush Administration:

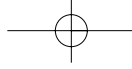
- ★ Installed more than 70 new federal judges—including many known foes of choice—and continued to nominate arch-conservatives to fill judicial vacancies.
- ★ Cancelled \$34 million in family-planning dollars to the U.N. Fund for Population Assistance.
- ★ Wrote federal regulations making “unborn children,” but not pregnant women, eligible for the Children’s Health Insurance Program.
- ★ Censored (and “revised”) medical and public-health information from federal government Web sites, including fact sheets on abortion and breast cancer, HIV and condoms, and sex-education programs.
- ★ Threatened to withdraw the United States from the Cairo Program of Action, an international blueprint, signed by 179 countries, for improving women’s health and autonomy.
- ★ Directed a federal advisory committee to consider embryos “human subjects”—a move that not only elevates embryonic “rights” but also potentially threatens promising biomedical research.

Some victories stood out among the year’s barrage of anti-choice activity. The Senate voted to repeal the ban on privately funded abortion services for women in the

military. (This position did not prevail in the House-Senate conference committee, however, and the ban continues in law.) Congress let stand the four-year-old contraceptive-equity law for federal employees. And after months of negotiations and deadlock, anti-choice Reps. Henry Hyde (R-IL) and James Sensenbrenner (R-WI) finally agreed to a compromise version of the Schumer clinic-violence amendment that would hold perpetrators of violence, harassment and intimidation responsible for their illegal acts. (Not to be outdone, hard-line anti-choice House members revolted, forcing the compromise language from the legislation and killing the entire bankruptcy bill in the process.)

But the 108th Congress promises to bring a new wave of assaults on reproductive rights. With bills, amendments, and arch-conservative judicial nominations already in the queue, anti-choice congressional leaders are promising rapid movement when Congress convenes. Legislation to criminalize abortion procedures, grant embryonic rights, hinder young women’s access to abortion, and withhold services and information from women are all considered likely. Anti-choice lawmakers are also expected to take action against family-planning services—including attempts to limit emergency contraception and/or mandate parental consent for family-planning services.





Anti-choice lawmakers are also poised to support President Bush's moves on the international front to limit women's access to abortion, contraception, and even basic health information. Anti-choice Sen. Orrin Hatch (R-UT), incoming Judiciary Committee chairman, boldly states his intention to move conservative Bush nominees at a very rapid clip - and warns Democrats not to exercise too vigorously their constitutional responsibility of advise and consent.

These are daunting times, indeed. But NARAL Pro-Choice America is mobilizing to build the ranks of pro-choice Americans who will fight back against attacks on our fundamental freedoms. In addition to defending against anti-choice legislation, judicial nominations and executive actions, we will proudly define a national pro-choice vision through a proactive legislative agenda.

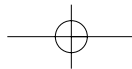
Our goals do not waver. They remain the protection and defense of the constitutional right to choose, and the promotion of policies that improve women's health, prevent unintended pregnancies, enhance healthy childbearing, and make abortion less necessary.



Editor's note: NARAL Pro-Choice America traditionally calculates lawmakers' records on reproductive-rights issues with percentages that represent the sum of the year's votes. Occasionally, however, the House or Senate will cast just one vote on a reproductive-rights issue during a session. In these years, lawmakers' numerical scores do not necessarily reflect the totality of their positions on reproductive rights.

The 2002 Senate session is a case in point, with only one vote on reproductive rights—the Murray-Snowe amendment to lift the ban on privately funded abortion services for women in the military—having been cast during the year. Each senator's numerical percentage for this year, zero or 100, represents his or her position on that one vote, not necessarily on reproductive rights broadly. For a more accurate picture, we recommend reviewing other years' voting records.

NARAL Pro-Choice America's mission is to protect and preserve the right to choose while promoting policies and programs that improve women's health and make abortion less necessary.

EXPLANATION OF 2002 SENATE VOTES

1. **Women in the Military.** FY'03 Department of Defense Authorization Act, S 2514. Murray (D-WA)/Snowe (R-ME) amendment to strike current law prohibiting military personnel and their dependents from obtaining privately funded abortions at overseas military hospitals. Current law allows exceptions only in cases of rape or incest. Passed 52-40; a pro-choice vote (+) was in support of the amendment (6/21/02).



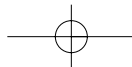


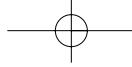

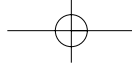




EXPLANATION OF 2002 HOUSE VOTES

1. Child Custody Protection Act of 2002. HR 476. Jackson-Lee (D-TX) motion to send the bill back to committee to substitute language that exempts from criminal prosecution grandparents, adult siblings, and religious counselors who accompany a minor across state lines for an abortion if the minor's home state parental-involvement mandate has not been met. Rejected 173-246; a pro-choice vote (+) was in support of the motion to recommit (4/17/02).

2. Child Custody Protection Act of 2002. HR 476. Final passage of the Ros-Lehtinen (R-FL) bill to subject to criminal prosecution anyone other than a parent - including a grandparent, adult sibling, or religious counselor - who accompanies a minor across state lines for an abortion if the minor's home state parental-involvement



ment mandate has not been met. Passed 260-161; a pro-choice vote (+) was against the bill (4/17/02).

3. Women in the Military. FY'03 Department of Defense Authorization Act, HR 4546. Sanchez (D-CA) amendment to strike current law prohibiting military personnel and their dependents from obtaining privately funded abortions at overseas military hospitals. Current law allows exceptions only in cases of rape or incest. Rejected 202-215; a pro-choice vote (+) was in support of the amendment (5/10/02).

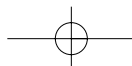
4. Abortion Procedures Ban. "Partial-Birth" Abortion Ban Act of 2002, HR 4965. Rule. Adoption of the rule (HRes 498) to provide for House consideration of an unconstitutional measure banning safe, common abortion procedures prior to fetal viability, with no exception to protect a woman's health. Under the bill, physicians could be jailed, fined, and/or subjected to civil lawsuits. The rule allowed no opportunity for amendments. Passed 248-177; a pro-choice vote (+) was against the rule (7/24/02).

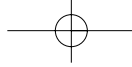
5. Abortion Procedures Ban. "Partial-Birth" Abortion Ban Act of 2002, HR 4965. Final Passage. Chabot (R-FL) bill to unconstitutionally ban safe, common abortion procedures prior to fetal viability, with no exception to protect a woman's health.

Under the bill, physicians could be jailed, fined, and/or subjected to civil lawsuits. Passed 274-151; a pro-choice vote (+) was against final passage (7/24/02).

6. National Refusal Clause. Abortion Non-Discrimination Act of 2002, HR 4691. Rule. Adoption of the rule (HRes 546) to provide for House consideration of a bill to allow any health-care entity (including hospitals, health insurance corporations, and HMOs) to exempt itself from any federal, state, or local law, regulation or policy that assures women have access to abortion services and information. By denying women access not only to abortion services themselves, but also to payment and referrals for abortion services, the bill effectively authorizes a back-door "gag" rule. The rule allowed no opportunity for amendments. Passed 229-194; a pro-choice vote (+) was against the rule (9/25/02).

7. National Refusal Clause. "Abortion Non-Discrimination Act of 2002," HR 4691. Final Passage of the Bilirakis (R-FL) bill to allow any health-care entity (including hospitals, health-insurance corporations, and HMOs) to exempt itself from any federal, state, or local law, regulation or policy that assures women have access to abortion services and information. By denying women access not only to abortion services themselves, but also to payment





and referrals for abortion services, the bill effectively authorizes a back-door “gag” rule. Passed 229-189; a pro-choice vote (+) was against final passage (9/25/02).
